My archery experience began in college where I was a member of the East Stroudsburg University Archery Team. On that team I was able to travel to Belgium and the College National Target Championships to compete. After graduating and getting married, my husband and I traveled from Pennsylvania to Alabama to train in archery with a coach for the '88 Olympic Trails from 1985-1988. During that time, I competed and became a member of the United States National Archery Team in '87, '88, '89. I was also invited to be one of the first 5 archery resident athletes at the Colorado Springs Olympic Training Center. I feel my experience as an elite archery athlete gives me a unique perspective to the goals and mission of USA Archery.

In my 26 year career with the VA, I started as a staff physical therapist at the Denver VA. From there I became the administrative director of the Rehabilitation Department at the Denver VA Medical Center. This was followed by being selected as a Rehabilitation Planning Specialist. In this position I worked for VA Headquarters in Washington DC but was field based in Denver. I gained tremendous experience in all aspects of running a national program in rehabilitation. This included things like writing Congressional responses, writing national handbooks and documents, managing a \$10 million budget, strategic planning, marketing VA programs to outside agencies and maintaining quality rehabilitation programs through an accreditation process. This business experience of running national programs I feel would be a tremendous asset to the USAA Board of Directors.

My passion at this time is in para archery however I also have a strong interest in seeing our US women on the podium at international events.
