Deadline:

Deadline for registration is July 31, 2019. Registrations received after this date may be accepted based on space available. For updates on availability, check with events@usarchery.org.

Team Rounds

Team round registration is subject to the same deadlines as individual registration

Mixed Team registration: \$10/team.

Team Round registration: \$15/team.

Team round registrations will be available until the field has reached capacity.

Waiver:

All participants must agree to the waiver that is attached to the registration prior to participating in tournament activities. Archers under 18 years of age must also have a parent or legal guardian sign the waiver. All athletes are bound by the USA Archery Athlete [Code of Conduct](#).

Membership Requirements:

U.S. Residents shall have:

- Current USA Archery Membership and proof of citizenship, or National Eligibility Form on file
- Adult NFAA members shall have Temporary NFAA Membership

Foreign athletes shall have:

- A Temporary USAA Membership for Foreign Nationals.

Eligibility Requirements for U.S. National Target Championships:

Any USA Archery member in good standing who is a U.S. Citizen is eligible to compete for a national title. If an athlete is not a U.S. Citizen they must have the written permission, and no longer be competing for, the Member Association of the country from which he/she has a valid passport to compete.

All other competitors shall compete in the Guest division.

Eligibility Requirements for U.S. Open: Participation in the NTC which serves as qualification.

Premium Seating:

Premium Seating will be offered for spectators as a general admission option. Premium seating is located adjacent to athlete seating under a canopy. Purchase this item as part of online registration or as a separate transaction. Price is \$50 for the duration of the event.

Coaching Credentials for Practice, Qualification and Elimination Rounds:

USA Archery credentialed coaches are allowed access on official practice days up to the targets. During scoring coaches are allowed up to the waiting line. A Coach Credential allows the bearer access to Premium Seating. There may not be more than one coach on the field for each athlete competing. All coaches must have the USA Archery coaching credentials when on the field of play. [Click here for the USA Archery Coaching Policy.](#)

New for 2019: Those wanting to purchase a coach credential shall have a current, clean Background screen and current SafeSport certification.

Coach credentials will be available for purchase on the USA Archery website and during Check-in on August 14, 2019. Price is \$70 for the duration of the event. [Link to purchase a Coach Credential.](#) Non-credentialed coaches shall remain in open spectator areas outside of the athlete area, premium seating and field of play.

Agents for Archers with disabilities:

If an archer is in need of an agent to assist with duties at the target or elsewhere, the archer should plan to bring the agent with them to the event. If they do not have an agent, they can contact the organizer of the event to see if they have an agent available, but the responsibility of having an agent lies with the archer. Credentialed persons assisting archers with disabilities or the tournament officials may sit within the archers' area.
