Summary: Individuals shall advise USA Archery staff members, making recommendations regarding the Junior Olympic Archery Development (JOAD) program and event administration to USA Archery staff. Individuals will also serve as one of four regionals representatives for the program.

As a JOAD Advisory Council Representative, you will be asked to:

- Advise USA Archery staff on JOAD Club and Event related issues
- Act as a resource to, and communicate with, State Associations and State JOAD Coordinators as needed
- Assist in the promotion of JOAD activities within their region
- Review USA Archery JOAD Award nominations after recommendations are received by USA Archery staff
- Attend JOAD Advisory Council meetings

Regional Representative:

- Candidate must be affiliated with a current JOAD or Both Club (Club Director, Club Coach or Club Member) Note: Club Coaches are not required to be Club Head Coach, but must be listed as an official coach with the club
- Candidate must have, and maintain, at minimum a current Range Pass (Membership, SafeSport, Background Screening) on file with USA Archery. Note: It is recommended the candidate have, and maintain, at minimum a current Level 2 Instructor Certification

Representative terms are two years* and are staggered to provide for program continuity. Representatives agree to and comply with USA Archery Code of Conduct and Code of Ethics ([Please see link here](#)). Service is an unpaid volunteer position. In addition to meetings, council service is anticipated to average 5-10 hours per year. The council is advisory in nature and reports to USA Archery staff. All official actions require CEO or Board of Directors approval.
