3. Current Mental Management 101 certificate (applicants need to complete this online course prior to the certification course)
4. Must be a permanent coach with a USA Archery Collegiate Program in good standing (full-time, salaried or university faculty not required, however should not be a student who is coach at a program and will leave role upon graduation)

2020 Level 4-NTS Course Grant Information

1. A certain number of coaches who attend the Level 3-NTS Coach course (above) as well as a number of existing Level 3-NTS Collegiate Coaches will be chosen from the applicant pool*
 - a. *An exception to the standard requirements to attend the Level 4-NTS course will be made for individuals selected from the Level 3-NTS course. All other applicants will be expected to meet Level 4-NTS course requirements.
2. USA Archery will notify applicants if their application was accepted/denied
3. Successful applications will choose to attend one of the following Level 4-NTS courses in 2020:
 - a. November 8-13, 2020 in Chula Vista, CA
 - b. December 6-11, 2020 in Statesboro, GA
4. Upon successful completion of the Level 4-NTS course and certification requirements, USA Archery will send individuals a check for up to \$850 to cover costs related to flights, transportation, lodging and food*.
 - a. *The registration fee for the Chula Vista course includes meals and housing, so checks sent to applicants attending the Chula Vista course will be \$400 and checks sent to applicants attending the Georgia course will be \$850
5. The course registration fee will be waived for selected applicants.
6. Please note: If courses are canceled as a result of COVID-19, USA Archery does not reimburse expenses related to airline tickets or other travel related costs.
