

Please review the steps for submitting a Record Claim *carefully*:

1. Be sure to have your scorecard signed by a recognized tournament official (preferably the Director of Shooting, or else the Head Judge, or both).
2. USA Archery Membership AND U.S. Citizenship are Required to Apply for Records.
3. In order for a record to be applicable, it must have been shot at an event that was registered as USA Archery Sanctioned event. For a record to apply for World Record status, the event must have been sanctioned by USA Archery AND registered as a Star FITA.
4. The rounds being applied for must be OFFICIALLY RECOGNIZED rounds by either USA Archery or World Archery (WA). There is a complete list on the web site.
5. If a record is shot at International Star FITA competition by a U.S. Citizen who is also a member of USA Archery (during the time of the event), the record will be applicable for submission.
6. An archer, properly registered for a tournament, may legitimately claim ANY record for which the score he/she shot exceeds an existing record, even if the record is in a higher division. For example, a cadet who shoots an indoor 600 round score that exceeds the existing record score of the Junior (or Senior) division may claim that record as well as the cadet division record. Also, if the archer registers "up" one or more divisions yet still exceeds the record for his/her natural division (i.e, a cadet registers as a JUNIOR and shoots a score that exceeds the existing cadet record for the distance shot) may lay legitimate claim to the cadet record even though the archer did not compete in that lower division during the tournament. Likewise, if an archer is old enough/qualified to compete as a Master 50+, and shoots a score that ties or exceeds an existing SENIOR record score, that archer can then claim that SENIOR record as well as the Master 50+ record, simply by executing properly the claim form process
7. **Deadlines:** if submitting for a World Record, the Records Claim Form and scorecard must be received within FIVE days of the event. If submitting for a National Record, the Records Claim Form and scorecard must be received within TEN days of the event.
8. Complete the Records Claim Form on page 2 of this document.
9. Complete the form in its entirety.
10. Email the completed Records Claim Form, and a legible copy of the archer's scorecard, to: [records@usarchery.org](mailto:records@usarchery.org)

All records are subject to verification. A printable Certificate of Accomplishment, in the form of an Adobe Acrobat file, will be emailed to the archer at the email address entered on the claim form.

# USA Archery - Record Claim Form



To submit a claim for a Start FITA, World or National record, please follow these steps:

- Star FITA or National Record: Submit Record Claim no later than **10 days** after the tournament.
- World Record: Submit Record Claim no later than **5 days** after the tournament **and with a copy of the official event results or link.**
- Fax or Email completed form.
- Include a legible photocopy of the score card(s) signed by both the competitor and the Judge or DOS or COJ.
- **ARCHERS ARE RESPONSIBLE FOR ACCURACY OF SCORECARD!**
- Be sure to complete all applicable fields in the Claim Form.
- Use multiple forms if more than 5 records claimed.
- Check your claim against current records posted here: <http://www.teamusa.org/USA-Archery/Events/Records>
- By signing you declare that the event was registered with USA Archery, conducted under World Archery rules, and that all the information you provide is accurate.
- Claims for World & Star FITA (but NOT "National") records can only be made at events registered with USA Archery or World Archery as "Star FITA" events.
- National records, which may also qualify as Star FITA & World Records, must be shot at "USAA National Championships"
