By applying for my (and/or my minor child's) membership and the privilege of participation in any activity ("Activity") with the National Archery Association of the United States (also known as "USA Archery"), I agree to be subject to, bound by, and observe all applicable provisions of the Bylaws, rules, codes, regulations, policies and procedures, and any other applicable governing documents of USA Archery, including the Code of Conduct and Ethics of USA Archery which can be found at [www.usarchery.org](http://www.usarchery.org), and any amendments thereto. In addition:

- I UNDERSTAND that dangers may be caused by me (or my minor child's) own actions or inactions, and by the actions or inactions of others, while participating in the Activity. I understand the nature USA Archery's activities and acknowledge my (or my minor child's) experience and capabilities in the sport, and believe I (or my minor child) am qualified to participate in such Activity. I further acknowledge that I am aware that the Activity will be conducted in facilities open to the public during the Activity. I further agree and warrant that if, at any time, I (or my minor child) believe conditions to be unsafe, I (or my minor child) will immediately discontinue further participation in the Activity.
