# T-SHIRT DESIGN CONTEST OFFICIAL RULES

This USA Archery contest is regulated by these Contest Rules (the "Rules"). Participation in the Contest constitutes the Participant's agreement and acceptance of these Rules. All federal, state, local, municipal laws and regulations apply.

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR CONTRIBUTION TO USA Archery WILL NOT INCREASE YOUR CHANCES OF WINNING.**

## ELIGIBILITY

This Contest is open to those who submit a design at [ebeach@usarchery.org](mailto:ebeach@usarchery.org) with the subject of "Tshirt Design Contest". You must be at least 18 years old as of the date of entry. If you are less than 18 years old, your parent or legal guardian must be the one submitting your entry. The Contest is only open to legal residents of the United States, and is void where prohibited by law.

Employees of USA Archery, Employees of Sponsor, and other companies associated with the promotion of the Contest, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, and immediate family members (spouse, parents, siblings, and children) and/or those living in the same household of Employees are not eligible to participate in the Contest. The Contest is subject to all federal, state, local, municipal laws and regulations.

## CONTEST PERIOD - START AND END DATE

Entries will be accepted online starting on April 23, 9:00 am PST and ending at May 7, 11:59 pm PST (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified.

## ENTRY RULES

The Contest must be entered by submitting a design via email at [ebeach@usarchery.org](mailto:ebeach@usarchery.org), which is also linked at [www.usarchery.org](http://www.usarchery.org). The design must meet all Contest requirements to be eligible to win a prize. Incomplete entries or the ones which are not in alignment with the rules, requirements, and specifications will be disqualified by USA Archery. You may enter the Contest only once and you need to provide any information that might be necessary. Any attempt of circumvention of the rules will result in immediate disqualification from the Contest.

## WEB ENTRIES

Participants must accurately complete all required information: name, address, email address, and phone number in an email addressed to [ebeach@usarchery.org](mailto:ebeach@usarchery.org) with the subject line "Tshirt Design Contest". Designs must be attached using any of these file formats: .jpeg, .gif or .png file, or the entry will be characterized as incomplete and will not qualify.

## ORIGINAL CONTENT; OWNERSHIP

By participating in the Contest, each Participant guarantees that they are the exclusive owner of the copyright and all other proprietary rights in any and all materials and content submitted by the Participant to enter the Contest, except for use of the USA Archery logo, if any, which shall at all times remain the property of USA Archery. Guidelines for use of the USA Archery logo are set forth in Contest Guidelines. The Participant further claims and guarantees that they have the right to grant to any third party the right to use, reproduce, distribute, perform and display any design file. All entries must have appropriate clearances, permissions and releases PRIOR to submitting, or may be eliminated from the Contest. Any unauthorized samples or performances of another artist's material could be subject to fines, royalty fees, and/or legal action for which the Participant agrees to indemnify, defend and hold USA Archery harmless. USA Archery may use any t-shirt design file on-demand on USA Archery's or its affiliates' websites.

## RIGHTS GRANTED BY CONTEST PARTICIPANTS

By entering this Contest and sending your design the Participant understands and agrees that USA Archery and/or anyone acting on behalf of USA Archery has the right, where permitted by law, to use the submission and non-identifiable personal information for purposes of promoting this Contest without limitation and without any further compensation, notice, review, or consent.

## DISCLAIMER OF RESPONSIBILITY

USA Archery is not responsible for problems with Contest entries, including but not limited to, entries which are lost, late, misdirected, damaged, incomplete, illegible, or cannot be completed due to electronic or technical difficulties, even if the problem is the result of the sole or partial negligence of USA Archery.

## PRIZES

Winner of the Contest (the "Winner") will receive a USA Archery Prize Pack. The grand prize winner will receive six (6) printed t-shirts bearing the grand prize winning design, a USA Archery water bottle, cell phone case and decal. Approximate retail value is \$200. The first runner-up will receive one (1) printed t-shirt bearing the design submitted by the first runner-up and a USA Archery water bottle. Approximate retail value \$75. The second runner-up will receive one (1) printed t-shirt bearing the design submitted by the second runner-up. Approximate retail value \$25.

Prizes cannot be redeemed for cash or substituted for another prize, and is non-transferable. Prize-related expenses including all federal, state, and local taxes represent the sole financial responsibility of the Winner. The prize is given with no written, express, or implied warranty. Any prize not claimed within 30 days will be forfeited by the winner and remain the property of USA Archery.

## WINNER SELECTION AND NOTIFICATION

Winner will be selected by USA Archery members and social media followers votes under the supervision of USA Archery. Winner will be informed about the prize by email and phone call within 3 days following the Winner selection to claim the prize. USA Archery is not responsible if the Winner fails to receive the notice about the prize due to any security settings or provision of incorrect contact information. If the Winner fails to respond within the required time period, the prize may be forfeited, and an alternate Winner may be selected based on votes. If the Winner is considered a minor in their place of residence, USA Archery reserves the right to place the prize in the name of the Winner's parent or legal guardian who will be requested to sign the Declaration of Claim on the Winner's behalf. Acceptance of the prize given in this Contest is in accordance with any and all federal, state, and local laws and regulations. If the Winner is disqualified for any reason, USA Archery is not obliged to provide an alternate prize or extend the Contest Period in any way, and all privileges as Winner will be terminated immediately.
